PUBLIC NOTICE DESTRUCTION OF NOXIOUS WEEDS & FINES ASSESSED

To All Property Owners in Appanoose County, Iowa

You are hereby notified that in accordance with the provisions of Chapter 317 of the Code of lowa and amended thereto, the Board of Supervisors and the appointed Weed Commissioner of Appanoose County Iowa declare the owners or persons in control of real estate within said county should destroy all weeds declared "noxious" by the Iowa Department of Agriculture and Land Stewardship that exist on real estate within Appanoose County, Iowa.

The following species of "noxious" weeds shall be destroyed by landowners in Appanoose County, lowa before the 15th of May and as often as necessary thereafter to prevent seed production and spread:

- -Musk Thistle
- -Red Sorrel (Sheep Sorrel)
- -Buckthorn
- -Curly Dock (Sour Dock)
- -Smooth Dock
- -Hoary Cress (Perennial Pepper Grass)
- -Leafy Spurge
- -Quackgrass
- -Multiflora Rose
- -Teasel

The following species of "noxious" weed shall be destroyed by landowners in Appanoose County, Iowa before the 15th of June and as often as necessary thereafter to prevent seed production and spread:

- -Canada Thistle
- -Buckhorn Plaintain
- -Russian Knapweed
- -Wild Mustard

The following species of "noxious" weed shall be destroyed by landowners in Appanoose County, Iowa before the 15th of July and as often as necessary thereafter to prevent seed production and spread:

- -Field Bindweed
- -Poison Hemlock
- -Bull Thistle
- -Horse Nettle

- -Perennial Sowthistle
- -Tall Thistle
- -Velvetleaf (Butterprint)
- -Wild Sunflower
- -Cocklebur
- -Wild Carrot
- -Puncturevine
- -Shattercane

The following species of "invasive" species shall be added to the Appanoose County, lowalist of noxious weeds and should be sprayed or otherwise controlled whenever they are found on lands in Appanoose County, lowa:

- -Purple Loosestrife
- -Phragmities (Reed Grass)

- -Garlic Mustard
- -Japanese Knotweed
- -Marijuana

In case of landowners and tenants failing to comply with an order to destroy weeds made pursuant to Chapter 317, the Weed Commissioner or designee may enter private lands five days after serving a destruction notice in order to conduct control on any weed infestation. The cost of this destruction, plus a 25 percent on the dollar fine shall be billed to the landowner if the bill is not paid; the cost of said destruction will be assessed to the tax rolls of the weed violator. Also, the Weed Commissioner may pose a fine for each day of non-compliance up to ten days at the rate of ten dollars per day.

Dear Mark:

The purpose of this Engagement Agreement ("Agreement") is to disclose and memorialize the terms and conditions under which Ahlers & Cooney, P.C. will represent Appanoose County, Iowa (the "County") in connection with its local option sales and services tax elections.

SCOPE OF ENGAGEMENT

We agree to perform the following services for the fees we charge under this Agreement:

It is not anticipated that it will be necessary for us to personally attend County meetings in order to accomplish our work. We will be coordinating our services with the Board and other County staff. In the event that public hearings or litigation should occur in the course of this matter, we would expect the same to be handled by the County Attorney, unless special arrangements are made for our participation.

ATTORNEY-CLIENT RELATIONSHIP

As confirmed by the execution of this Agreement, the County will be our client and an attorney-client relationship will exist between us for the services described above. Our services are limited to those contracted for in this Agreement and the County's execution of this Agreement will constitute an acknowledgement of those limitations. The Firm's engagement under this Agreement will end when election has been called and our final invoice has been paid.

FEES

I will be the attorney chiefly responsible for providing you with these legal services. However, if efficient and appropriate, I may call on other attorneys and legal assistants from time to time. The fees will be based on the hours worked by firm personnel at their hourly rates in effect at the time the work is performed. Our rates are generally adjusted on an annual basis, beginning January 1 of each year. For 2020, my hourly rate is \$295, and my legal assistant's rate is \$120. It is difficult to estimate the total cost for the work, because we charge by the hour and there are many variables that impact the number of hours spent on the work. Expenses will be billed at the amount incurred. Our statement for services and expenses will be due and payable upon receipt of the invoice, which in most instances, is monthly. Should you have any questions about a statement or a fee, please do not hesitate to call. We do reserve the right to withdraw from representation for any reason, including failure to pay the monthly statement in accordance with this policy. If, for any reason, the County terminates the engagement governed by this Agreement before the completion of the services described herein, we will bill the County for the services rendered as of the date of termination based on the hourly rates of those who provided services.

RECORDS

At the County's request, any documents furnished by the County will be returned promptly upon receipt of payment for outstanding fees and client charges. Our own files, including lawyer work product, pertaining to the above referenced project will be retained by us. For various reasons, including the minimization of unnecessary storage expenses, we reserve the right to dispose of any documents or other material retained by us after the termination of this Agreement.

If this Agreement accurately reflects the terms of this particular engagement, please obtain approval by the Board of Supervisors, and execute, date, and return to me the enclosed copy of this Agreement. Please retain the original for your file.

RESOLUTION CALLING FOR AN ELECTION ON THE QUESTION OF A CHANGE IN USE OF A LOCAL OPTION SALES AND SERVICES TAX REVENUES IN THE UNINCORPORATED PORTION OF APPANOOSE COUNTY, IOWA

WHEREAS, the Board, proposes to change the use for local option sales and services tax revenues allocated to the unincorporated portion of Appanoose County, Iowa; and

WHEREAS, Chapter 423B of the Code of Iowa, provides that before the Board may change the use of local option sales and services tax revenues it shall call a special county election to vote upon the proposition of issuing said bonds in accordance with the provisions of said statute; and

WHEREAS, the "______" is a legal newspaper, printed wholly in the English language, as defined by Section 618.3 of the Code of Iowa, and is published in said County and of general circulation therein;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF APPANOOSE, STATE OF IOWA:

Section 1. That there is hereby called a special county election on Tuesday, the 8th day of September, 2020, at which election there shall be submitted to the registered voters of the unincorporated portion of Appanoose County, Iowa the following question, to-wit:

Summary: To authorize a change in the use of one percent (1%) local sales and services tax in the unincorporated area of the County of Appanoose effective January 1, 2021.

The use of the one percent (1%) local sales and services tax shall be changed in the unincorporated area of the County of Appanoose effective January 1, 2021.

PROPOSED USES OF THE TAX:

If the change is approved, revenues from the sales and services tax shall be allocated as follows:

0% for property tax relief.

The specific purposes for which the revenues shall otherwise be expended are:

100% for a new law enforcement center or any other lawful purpose.

CURRENT USES OF THE TAX:

Revenues from the sales and services tax are currently allocated as follows:

60% for property tax relief, exclusively in the unincorporated area of the County.

The specific purposes for which the revenues shall otherwise be expended are:

20% to the secondary road fund for additional expenditures for mowing, brush cutting, and ditching.

20% for infrastructure for economic development and may be used as matching funds for grants to accomplish the intent of this section.

Section 2. That the voting place or places for said election, and the hours the polls shall be opened and closed shall be as set out in the notice of election, said notice to be prepared and approved by the County Commissioner of Elections.

Section 3. That the form of ballot to be used at said election shall be as follows: (a) in those precincts using paper ballots they shall be printed on some color other than white, pursuant to the provisions of Section 49.43 of the Code of Iowa; substantially in the form set forth in the Notice of Election, and (b) in those precincts using voting machines, if any, they shall be printed in black ink on clear, white material, of such size as will fit the ballot frame, and in as plain, clear type as the space will reasonably permit, pursuant to the provisions of Section 52.10 of the Code of Iowa, substantially in the form set forth in the Notice of Election. That said notice shall show the names of all candidates or nominees and the office each seeks, if any, and if more than one public measure shall be submitted to the electors at the time of the said election, all such measures shall be printed upon one ballot.

Section 4. That the Election Board for the voting precinct or precincts shall be appointed by the County Commissioner of Elections, not less than 15 days before the date of said election.

Section 5. That the Auditor of Appanoose County, Iowa, being the County Commissioner of Elections, is hereby directed to publish the notice of election twice in the "_______", being a legal newspaper, printed wholly in the English language, as defined by Section 618.3 of the Code of Iowa, published in said County and of general circulation therein the first publication shall be not less than 60 days before said election. The second notice, including a sample ballot shall be published not less than four clear days nor more than twenty days prior to the date of said election.

Section 6. That the County Commissioner of Elections shall cause to be prepared all such ballots and election registers and other supplies as may be necessary for the proper and legal conduct of said election.

Section 7. That the Auditor is hereby directed to file a certified copy of this Resolution in the office of the County Commissioner of Elections, which filing shall also constitute the "written notice" to the County Commissioner of Elections of the election date required to be given by the governing body under the provisions of Chapter 47 of the Code of Iowa.

WHEREAS, Chapter 423B of the Iowa Code (the "Code") establishes the requirements to request that the County Commissioner of Elections hold an election on the question of imposing a local sales and services tax; and

WHEREAS, the local sales and services tax currently imposed in Appanoose County, lowa will expire on June 30, 2023; and

WHEREAS, the Board of Supervisors of Appanoose County, Iowa, to avoid a lapse in the collection of local sales and services tax revenues, desires that an election on the imposition of a new local sales and services tax, effective July 1, 2023, be placed on the ballot for the September 8, 2020 election pursuant to Iowa Administrative Code Section 701-107.2(2).
