Gary Bishop, Interim County Engineer, updated the board on Secondary Roads projects. A couple employees will be retiring and there is an opening for a laborer position currently. They have had issues with the Udell maintainer (M-8) and will be traveling to CAT to talk to them. Advertisements for the Engineer position are out. There will be a right-of-way vacation for the next meeting. PAR will be working in Appanoose County and will restore roads to current conditions. Smith recommended taking a video of the roads before work is started. They have also started hauling rock.

Stephanie Koch, CDS Coordinator, reported that she attended ISAC last week where there was talk of children's services being transferred to the regions. The next Governing Board meeting is the 19<sup>th</sup> in Ottumwa at 10:30 A.M. Stakeholders will be 4/10/19 at 10 A.M. in Ottumwa. She will be training others to provide C3 Training next month. Mobile Crisis is up and going. 4-6 people have been using it a month with half coming from Appanoose County.

Sarah Lind, AEDC Director requested \$60,000 over 10 years from the economic development fund for a business wishing to expand in Appanoose County. AEDC and the city must approve commitments before the project will be a go. Demry motioned to approve the funding based on all other incentives being approved. Seconded by Smith. All voted aye.

Public comments: Bruce Buttel stated our population is decreasing our taxes are increasing and requested all elected officials (county, city & school) be reasonable with what we can afford.

Demry motioned to adjourn. Seconded by Smith. All voted aye.

The Board adjourned to meet at the call of the Auditor at 9:49 A.M.
