Meeting started with the Pledge.

Demry motioned to approve the agenda with the addition of Lefty's, Dirty & Mo liquor license. Seconded by Smith. All voted aye.

Demry motioned to approve bills. Seconded by Smith. All voted aye.

Demry motioned to approve the liquor licenses for Backpacket Brewing, Albia Brewing Company (pending dram), Honey Creek Resort, K.C's Landing, and Lefty's, Dirty & Mo (pending dram). Seconded by Smith. All voted aye.

Jason Murphy, GIS Administrator stated the City of Centerville already got the GIS information they needed and requested the board grant authorization to prepare an agreement which would prevent future timing issues. Waits requested Murphy draft an agreement for the board to approve.

Demry motioned to approve giving Appanoose County Coalition of the Arts \$10,000 for the Save the Square Project and if there is no award given the funds will be returned to the county. Seconded by Smith. Demry & Smith voted aye. Waits voted nay.

Smith motioned to reappoint Arthur Kirchoff to a 5 year term on the Conservation Board. Seconded by Demry. All voted aye.

Smith motioned to approve the 5/2019 update and addendum to the County Handbook. Seconded by Demry. Smith and Demry voted aye. Waits voted nay.

Demry motioned to close the Courthouse to the public July 24<sup>th</sup>, but personnel that do not volunteer to work RAGBRAI must report to work. Seconded by Smith. All voted aye. Restrooms will be open to the public.

County Engineer Brad Skinner, updated the board on Secondary Roads projects. There were some downed trees and branches but no structural damage. They've opened the box culvert at the yard and found the blockage. It will get replaced when the new tanks are also replaced this year. The slide on 614<sup>th</sup> Street has been repaired. Most of the mowing in the NW section has been completed.

Stephanie Koch, CDS Coordinator, informed the board the office will be closed Thursday and Friday this week. Starting July 9<sup>th</sup>, every Tuesday afternoon she will be at the jail for the jail aversion program. They are looking to get Stakeholders established in all counties for children. A plan is due to the state by April.

Public comments: Steve from Backpacket Brewing asked if the liquor license was approved. Dianna Daly-Husted reported to the board they are currently planning for RAGBRAI. The board should also consider passing an ordinance with regards to tanning beds as the state will no longer be inspecting them. She also spoke about grant funding for well plugging, shocking and assessments. Testing is free of charge. Jason Murphy recommended the board look into passing an ordinance on building codes.

Demry motioned to adjourn. Seconded by Smith. All voted aye.

The Board adjourned to meet at the call of the Auditor at 9:33 A.M.
